

# House rules Doka

Welcome to sound bar Doka. We are open towards anyone with an open-minded attitude towards other guests and who feel a sense of connection to the ongoing event. The minimum age to enter is 18+ and legitimation is mandatory. Doka holds the right to deny access to anyone, whether in possession of a (presale) ticket or not. Always follow directions by Doka and its staff and keep in mind that visitors may be searched at all times when requested.

## No

- Form of oppression and exclusion, such as homophobia, transphobia, sexism, ableism, racism, ageism, misogyny, vandalism, hooliganism, body shaming, and islamophobia.
- Inappropriate behavior, such as being aggressive or rude.
- Forms of (sexual) intimidation, such as inappropriate comments, harassment, stalking, and violence.
- Consumption of personal beverages or food.
- Ownership, use, or trade of hard drugs and/or weapons.
- Entry for visitors who are under the influence of alcohol and/or drugs.
- Jackets and/or bags. Please use the lockers or other wardrobe possibilities on the ground floor before entering.
- Gala wear, business suits, uniforms, or other clothing (or none) that is not part of the dress code. Doka encourages individuality, experimentation, and self-expression in guests' attire. Therefore, please refrain from wearing formal wear. We do not accept hateful or hurtful signs and messages on clothing.
- Flip flop and/or slippers. Due to safety reasons, any other forms of open shoes can only be worn at your own risk.
- Smoking and/or vaping inside Doka. Smoking of cigarettes and vapes are only permitted in the designated outdoor smoking area.

\* Failure to adhere to the above rules may result in being denied entry or being removed from the venue.

## Do note

- We do not accept cash payments at Doka.
- Large groups, bachelor parties, and other groups that significantly influence the atmosphere may be refused entry (maximum size of 4 people).
- If you experience or notice any form of harassment, please report it to bar staff on duty. Our employees are instructed to ensure the safety of our visitors. In case you want to file a notification (about e.g. harassment) once the event is over please reach out to [support-doka@volkshotel.nl](mailto:support-doka@volkshotel.nl).
- In case of denied entry, pre-sale tickets are refunded upon request.
- Please use your telephones as little as possible. Respect the privacy of others. If you're taking a photo anywhere in Doka, please don't use flash.
- Doka is not liable for any loss or damage to guests' personal belongings.
- Our lighting may not be suitable for individuals who have had a stroke or suffer from epilepsy and we cannot be held responsible for any adverse effects.
- We reserve the right to make exceptions to our door policy on a case-by-case basis, at the discretion of the door staff. If you have any questions or concerns about our door policy, please don't hesitate to ask a member of our bar and door staff.

## Club ethics

Doka endorses the *ClubEthics Manifest* and *Code of Safer Clubbing*. This means that we advocate the following principles.

- In Doka you are free to be who you are, and express yourself as such as long as your behaviour aligns with the house rules set by Doka.
- Look out for yourself and others. Doka's bar staff is trained to recognize and act on intimidation and unacceptable behaviour with the right measurements. All forms of inappropriate behaviour, whether towards yourself or someone else, can be confidentially reported to our staff. They will accommodate you and will look for a suitable solution.
- Inform bar staff if you or somebody else feels unwell for any reason. They will be there to help and not get you into trouble.
- Consent is key. Only yes means yes. Everything else means no.
- All issues reported to Doka are anonymously registered, saved, and internally evaluated.
- Always be mindful of the space you're entering and the space you take up.
